Motion by Mr. Courville seconded by Mr. Sanders and carried to accept the minutes of the meeting held June 7, 2021.

The Finance Committee had the following recommendations:

- 2) Approve to pay Donald Perkins \$1,600.00 for repairs to backhoe and dump truck for RD5.
- 3) Approve to pay H&E Equipment \$1,655.28 for repairs to motor grader for RD4.
- 4) Approve to pay Cottons Heating and Cooling to replace an A/C unit at the parish jail.

Motion by Mr. Courville seconded by Mr. Sanders and carried to adopt a resolution permanently relocating Precinct 2-6 from the Kinder Hospital to the Kinder Fire Station.

Motion by Mr. Strother seconded by Mr. Sanders and carried to reject bids on Ward 5 barn.

Motion by Mr. Courville seconded by Mr. Sanders and carried to approve COLA increase.

Motion by Mr. Sanders seconded by Mr. Courville and carried to reappoint Emma Young to the Recreation District #6 Board for a 5-year term.

Motion by Mr. Courville seconded by Mr. Sanders and carried to hire Dillion Davidson full time in RD4 at \$12.00 per hour contingent upon meeting hiring requirements.

Recognized Mrs. Sonnier to present the monthly inmate report. Expenses for the month of July 2021 totaled \$9,841.16. We are under budget \$7,458.84 for the month and \$53,748.71 for the year. Currently there are 74 Parish and 11 DOC.

Recognized Mr. Joel Johnson for report on the airport.
