

## POLICE JURY MEETING – October 4, 2021

The Allen Parish Police Jury met in regular session at the Police Jury Administration Building, Oberlin, Louisiana, October 4, 2021 at the hour of 6:30 p.m.

Present: Tony Hebert, Allen Courville, Heath Ardoin, Ruffin George, and Creig Vizena.  
Absent: John Strother, Chad Sanders

Motion by Mr. Vizena seconded by Mr. George and carried to go into session.

The Lord's Prayer was said followed by the Pledge of Allegiance.

Motion by Mr. Vizena seconded by Mr. Courville and carried to accept the minutes of the meeting held September 4, 2021.

The Finance Committee had the following recommendations:

- 1) Approve to pay Terminix \$1,904.00 to kill termites at the Airport House.
- 2) Approve to pay Covington Sales & Service \$2,272.53 to repair the boom axe for RD2.
- 3) Approve to pay Doggett Machinery \$1,728.10 to repair dozer for RD1.
- 4) Approve to pay H&E Equipment \$2,356.17 to repair track hoe for RD3.
- 5) Approve to pay Harmon's \$3,200.00 to install a 80 gallon commercial hot water heater at the Civic Center.

Motion by Mr. Vizena seconded by Mr. Courville and carried to accept the recommendations of the Finance Committee.

The Road Committee had the following recommendations:

1. Approve a JSA with the City of Oakdale for grass cutting, pothole patching and trash pick up for the month of October 2021.
2. Approve a JSA with the Town of Oberlin for manpower and equipment to repair a water main.
3. Approve a JSA with Fire District 6 for manpower and equipment to assist in removing debris from a burning dumpster.

Motion by Mr. George seconded by Mr. Courville and carried to accept the recommendations of the Road Committee.

Motion by Mr. Vizena seconded by Mr. Courville and carried for the purchasing agent to take necessary action for fuel, materials, and supplies for the month.

Motion by Mr. Courville seconded by Mr. Ardoin and carried to adopt a resolution to confirm an election date change per the Governor's Proclamation.

Motion by Mr. Courville seconded by Mr. Ardoin and carried to approve a CEA with the Louisiana Department of Veterans Affairs \$6,972.00 for expenses.

Motion by Mr. Vizena seconded by Mr. Courville and carried to award the RFQ for the Drainage Improvement Project.

Motion by Mr. Ardoin seconded by Mr. Vizena and carried to adopt a resolution for the Off System Bridge Replacement program.

Motion by Mr. Vizena seconded by Mr. Courville and carried to approve the Capital Improvement Project list.

Motion by Mr. Vizena seconded by Mr. Ardoin and carried to approve to hire Elmer Chapman Jr. part time parish wide Solid Waste/Road Crew for \$13.76 per hour contingent upon meeting hiring requirements.

Motion by Mr. Ardoin seconded by Mr. Courville and carried to accept the resignation of Glen Bledsoe from the Allen Parish Tourism Board and appoint Angela Hayward to complete his term.

Motion by Mr. Courville seconded by Mr. Ardoin and carried to Accept the resignation of Dale McGee from the FD4 Board and appoint Bobby Kibodeaux to complete term.

Recognized Ms. Sonnier to present the monthly inmate report. Expenses for the month of September 2021 totaled \$11,229.60. We are under budget \$6,070.40 for the month and \$74,707.89 for the year. Currently there are 68 Parish and 12 DOC.

Recognized Mr. Johnson for report on the airport.

Motion by Mr. Vizona seconded by Mr. Courville and carried to add item to the agenda:

1. Approve to accept LCAP contract for \$24,347 for the Northwest Allen Water District service truck.

Motion by Mr. Vizona seconded by Mr. Ardoin and carried to accept the LGAP contract for the Northwest Allen Water District service truck.

Motion by Mr. Vizona seconded by Mr. Courville and carried to adjourn the meeting.
