January 10, 2022

The Bremer County Board of Supervisors met in session on Monday, January 10, 2022 in the Courthouse, Waverly, Iowa, at 8:00 a.m. Hildebrandt, Neil, Kammeyer present. Kassandra Johansen, Finance Director, also present. Unless otherwise noted all actions were approved unanimously. Meeting was called to order by Chairman Hildebrandt. Kammeyer moved/Neil second to approve the agenda with Barb Meeker, Human Resources review/act on Bremer County's Vaccination, Testing, and Face Covering Policy being cancelled due to Iowa OSHA not following the Federal OSHA mandate. Anelia Dimitrova, Waverly Newspapers Editor, present.

Kammeyer moved/Neil second to approve the 1/2/22 minutes.

Public comment: Dimitrova inquired further into the details of the cancelled agenda item.

Kammeyer moved/Neil second to approve claims as listed below and authorize Auditor to issue checks.

Neil moved/Kammeyer second to accept and place on file, quarterly reports from the Auditor, Recorder, and Sheriff.

Shelley Wolf, Auditor, presented billing compilation scenarios for invoicing the cities & schools for the combined 2021 election and sought permission to proceed with invoicing the same as the 2019 combined City/School election was billed.

Neil moved/Kammeyer second to approve revisions to the Community Based Services Policy – "On-Call Time", altering which staff is required to be on call.

Dimitrova exited.

Board reviewed Wellmark Health Insurance Renewal FY23 quotes. No action taken on setting the county contribution & employee contribution.

Board discussed making appointments to the Emergency Medical Services System Advisory Council.

Board recessed 8:50 a.m. to 10:00 a.m.

Hildebrandt & Neil met as part of the Bremer-Waverly Law Board at 9:00 a.m. Minutes taken by Dan Pickett, Sheriff.

Board met with Landon Moore, Engineer, for a weekly Secondary Roads department update.

Board further discussed making appointments to the Emergency Medical Services System Advisory Council. A public ad will be composed to be reviewed 1/17/22 to potentially be used for seeking interested qualified citizens in addition to those already known.

Board reviewed the FY23 Mental Health budget.

Board met with Nate Koehler, MIS, to review potential purchases of Tyler Financial (Incode 10) add on modules.

Koehler also informed the board that the cost of the Courthouse phone lines, as a result of changing to Waverly Light & Power, is now a quarter the cost that it was.

Kassandra Johansen, Finance Director, presented FY22 proposed budget amendments. No action taken on setting a Date & Time for a Public Hearing.

Board met with Scott LaRue, GIS/Maintenance, for a FY23 budget work session.

Board discussed developing an American Rescue Plan Act (ARPA) grant application process and who the grant would be made available to.

Board met with Shelley Wolf, Auditor, for a FY23 budget work session.

Board met with Lindsey Lambert, Building & Zoning Admin., to consider a subdivision request. Lawain Biermann & Kip Ladage present. Board further discussed the ARPA grant application process and subsequently discussed the ARPA EMA/Public Health building project with Kip Ladage, Emergency Management/Safety & Risk Mgr.
