

**CARIBOU COUNTY ORDINANCE NO. 2023-05**

AN ORDINANCE OF CARIBOU COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF IDAHO, REPEALING CARIBOU COUNTY ORDINANCE 2021-02 THAT ESTABLISHED CARIBOU COUNTY CODE CHAPTER 12.20 SECTION 030 “DIVISION OF AGRICULTURAL ZONED LAND”; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, Section 12.20.030 of the Caribou County Code does not align with the Caribou County Comprehensive Plan; and

WHEREAS, Section 12.20.030 of the Caribou County Code is not in the best interest of preserving the Agriculture Land within the County; and

WHEREAS, Section 12.20.030 of the Caribou County Code is not accordance with Caribou County Code Section 13.12.080 Minimum Lot size; and

WHEREAS, in accordance with Idaho Code, Caribou County has complied with all the notification and hearing requirements.

NOW, BE IT ORDAINED BY the Board of County Commissioners of Caribou County, Idaho.

**SECTION 1: REPEALING SECTION 12.20.030 OF THE CARIBOU COUNTY CODE TITLED “12.20.030 DIVISION OF AGRICULTURAL ZONED LAND”**

That Caribou County Ordinance #2021-02, Section 12.20.030 of the Caribou County Code, titled “12.20.030 Division of Agricultural Zoned Land”, be repealed upon effective date of this ordinance.

**SECTION 2: SEVERABILITY**

Should any word, clause, phrase, sentence, paragraph, subsection, or other part of this ordinance or any particular application thereof be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this ordinance.

**SECTION 3: EFFECTIVE DATE**

This ordinance shall be repealed after its passage approval and publication according to law.


**SECTION 4: ORDINANCE READING AND ADOPTION**
