REGULAR COUNCIL MEETING – DECEMBER 4, 2013 @ 6:30 P.M.

• **CALL TO ORDER.**

Mayor Hill called the meeting to order at 6:30 P.M.

• **PLEDGE OF ALLEGIANCE.**

1. APPROVAL OF AGENDA.

MOTION: Councilor Ring made a motion to approve the Agenda. Councilor Simmons seconded the motion for discussion.

MOTION: Councilor Ring amended his motion to amend the Agenda to exclude Item #7. Councilor Simmons seconded the motion.

VOTE: Councilor Simmons voted aye. Councilor Abrams voted aye. Councilor Abraham voted aye. Councilor Ring voted aye. The motion carried.

2. APPROVAL OF CONSENT AGENDA.

- B. Acknowledge Receipt of the Planning & Zoning Commission Meeting Minutes of November 19, 2013. (This Meeting was cancelled due to lack of a quorum).

MOTION: Councilor Abraham made a motion to approve the Consent Agenda. Councilor Abrams seconded the motion.

VOTE: Councilor Ring voted aye. Councilor Abraham voted aye. Councilor Abrams voted aye. Councilor Simmons voted aye. The motion carried.

3. MATTERS FROM THE MAYOR.

A. In-fill Annexation Discussion.

Mayor Hill stated he discussed the In-fill Annexation with Mr. Rael. Mr. Rael is communicating with Santa Fe County on some of the road issues. Mayor Hill asked Council if they wanted to pursue this Annexation. Councilor Ring stated it had gone this far, and he feels that the Town should pursue the in-fill annexation. Councilor Simmons agreed with Councilor Ring, and requested someone talk to Santa Fe County on vacating the roads. Mayor Hill stated he felt it made sense to consider, as code enforcement issues are compiling. Mayor Hill stated he would like to address the roads as part of the in-fill annexation, as this would provide for better infrastructure. Councilor Simmons

inquired about the Boundary Commission and what changes it would bring with the sewer and water. Mayor Hill stated that there was not going to be enough change to be compelling to not pursue the annexation, and the Town had been misinformed. Councilor Abraham felt the Town should pursue the Annexation as did Councilor Abrams. Councilor Simmons inquired about the process of annexation, if there is one acre among the Town of Edgewood property could this be annexed. Mayor Hill stated that it would be looked into, the Town could go to the Boundary Commission to begin the process and annex after moratorium.

Mayor Hill introduced Scout Troop 465. Three Scouts were present.

B. Appointment of Planning & Zoning Commissioner – Ms. Krista Cashatt. Mayor Hill reviewed Krista Cashatt’s resume with the Council. Ms. Cashatt stated she looks forward to working with the Town of Edgewood.

MOTION: Councilor Simmons made a motion to appoint Ms. Krista Cashatt as Planning & Zoning Commissioner. Councilor Ring seconded the motion.

VOTE: Councilor Simmons voted aye. Councilor Abrams voted aye. Councilor Abraham voted aye. Councilor Ring voted aye. The motion carried.

The Road Crew would start at 4:30 a.m. or earlier, go to Edgewood 7 and Windmill, and also start on the roads with hills and work north returning to the roads with hills as needed.

Councilor Abrams suggested that 5 hours was a long time, requested a look at equipment in the budget. Councilor Abrams also asked if the graders were being used to help clear the roads.

Council felt the Town should look at contracting for snow removal. Mayor Hill stated that there are too many liability issues to contract for snow removal.
