An Ordinance Relating to Streets and Sidewalks

Be it Ordained by the City Council of the City of Haverhill that the Code of the City of Haverhill, Chapter 222, as amended, is hereby further amended by adding the following at the end of said Chapter

"ARTICLE XV – WATER DISCHARGE ON PUBLIC WAYS

§222-96 Prohibited activity.

No person, owner of property, or person controlling property shall discharge or permit to be discharged into or upon any street, court, lane, public roadway, or roadway to which the public has a right to use, any water so as to create a public safety hazard by freezing or flooding of the roadway. §222-97 Violations and penalties.

Any violation of said article shall be subject to the payment of a fine not exceeding \$300 for each violation, each day representing an independent violation."
