

City of Haverhill City Council Minutes Tuesday, April 28, 2020 VIRTUAL MEETING

Present – President Barrett, Councillors LePage, Bevilacqua, Michitson, Sullivan, Jordan, McGonagle, and Macek.

President Barrett, Vice President LePage and City Clerk Koutoulas participated from the City Council office.

President Barrett read the following statement: This meeting of the Haverhill City Council is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus".

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible *physical* location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting.

Ensuring public access does not ensure public participation unless such participation is required by law. This meeting will not feature public comment.

Due to the ongoing COVID-19 Pandemic, Governor Baker issued an Emergency Order temporarily suspending certain provisions of the Open Meeting Law, G.L. c. 30A sec. 20. Public bodies otherwise governed by the OML are temporarily relieved from the requirement that meetings be held in public places, open and physically accessible to the public, so long as measures are taken to ensure public access to the bodies' deliberations "through adequate, alternative means."

ROBERT WARD GAVE A DETAILED SUMMARY OF THE COMBINED SEWER OUTFLOW (CSO) ISSUE IN HAVERHILL. HE EXPLAINED THE 3 ENGINEERING PHASES THAT THE CITY HAS UNDERTAKEN TO ADDRESS THE ISSUE. WE ARE IN PHASE 3. FLOW METERS WERE INSTALLED IN 2014 IN ALL CSO OUTFALLS. OUR OUTFLOW IS IMPACTED BY ANNUAL RAINFALL. SINCE 2014 THE VOLUME HAS BEEN MEASURED. THE RANGE FROM 2014/2015 WAS 8MILLION GALLONS TO 49MILLION GALLONS IN 2018. COUNCILLORS RAISED CONCERNS ABOUT THE CITY POSTING OF CSO VERSUS THE ACTUAL DISCHARGE INTO THE MERRIMACK RIVER. MR. WARD INFORMED THAT THE ANNUAL REPORT REPRESENTS AVERAGE RAINFALL AND AVERAGE GROUND WATER LEVEL. HE IS TAKING A LOOK AT THE WEBSITE TO SEE HOW IT CAN BE IMPROVED. COUNCILLORS WANTED THE WEBSITE TO REFLECT ACTUAL OUTFLOW. ALL AGREED THAT THE CSO ISSUE IS VERY COSTLY.

Communication was received from Councillor Timothy Jordan requesting to discuss the Hope in Haverhill inspirational messaging program in downtown Haverhill

COUNCILLOR JORDAN INFORMED ABOUT INSPIRATIONAL MESSAGING THAT IS GOING ON DOWNTOWN TO BRIGHTEN LIVES/UPLIFT SPIRITS AND WANTED TO GIVE A SHOUT OUT TO THOSE COMPANIES SUCH AS THE FOTO FACTORY, HARBOR PLACE, UMASS LOWELL, BATTLEGROUNDS COFFEE AND PENTUCKET BANK THAT HAVE DECORATED THEIR WINDOWS.
