TODD GAVE AND OVERVIEW OF THE 3 GROUP HOMES IN HAVERHILL RUN BY HER AGENCY. CHANGES IN STATE LAW HAS IMPACTED HOW THEY DEAL WITH STUDENTS WHO RUN AWAY FROM THE GROUP HOMES. THEY ARE NOT ALLOWED TO RESTRAIN THEM FROM LEAVING AND POLICE CAN NOT ARREST THEM UNLESS THEY HAVE COMMITTED A CRIME. MR. TUTTLE STATED THAT THEY CHANGED THEIR POLICY 6 WKS AGO WHICH HAS REDUCED CALLS TO POLICE DEPT.THIS IS A STATE-WIDE ISSUE.
