- 5 You must submit an additional \$157 per map sheet exceeding 2 sheets to the Public Works Department as part of your final map project review.
- 6 BUILDING PERMIT REVIEW FEES: Planning Department review fees associated with a building permit are collected by the Building Department (see County Fee Schedule Section 13.20.300 of the Yuba County Code for fees).
