**RESOLUTION NO. 2022-242**

**WHEREAS**, the California Department of Boating and Waterways performs boating safety enforcement activities on waterways within the state; and

**WHEREAS**, the County of Yuba has a need for boating safety enforcement on waters under its jurisdiction; and

**WHEREAS**, pursuant to the requirements of California Harbors and Navigation Code section 663.7 and the California Code of Regulations Title 14, Division 4, Chapter 1, Article 4.5.1, the County of Yuba is eligible and entitled, on an annual basis, to apply for and receive state financial aid for boating safety and enforcement programs on water under its jurisdiction; and

**WHEREAS**, pursuant to the requirements of California Harbors and Navigation Code section 663.7 (e) The department shall not allocate funds to any county or a public agency within a county unless the department receives a resolution adopted annually by the board of supervisors authorizing the county to participate in the program and certifying that the county will expend for boating safety programs during that year not less than an amount equal to 100 percent of the amount received by the county from personal property taxes on vessels. The money allocated to a county pursuant to subdivision (a) shall be used only for boating safety and enforcement programs as specified in subdivision (a), that are conducted in that county.

**NOW, THEREFORE, BE IT RESOLVED**, the Yuba County Board of Supervisors hereby makes the following determinations:

1. Sheriff Wendell Anderson is hereby authorized to execute on behalf of the County of Yuba that certain State Application for Financial Aid and Financial Aid Agreement for the Boating Program, Fiscal Year 2023-2024, in the form of copies thereof on file with the Clerk of the Board of Supervisors of the County of Yuba.
2. Sheriff Wendell Anderson is hereby authorized to execute quarterly and annual activity report for the Boating Program, for Fiscal Year 2023-2024.

3. Yuba County Auditor, C. Richard Eberle, is hereby authorized to execute on behalf of the County of Yuba, the 'estimated boat taxes' and quarterly claims for reimbursement for the Boating Program, for the Fiscal Year 2023-2024.






