RESOLUTION NO. 2022-182

WHEREAS, the County of Yuba has been included in several Federal Disaster Declarations administered by the State of California Governor's Office of Emergency Services, and

WHEREAS, the State of California Governor's Office of Emergency Services requires a Designation of Applicant's Agent Resolution for Non-State Agencies to be on file for the purpose of obtaining certain federal assistance under Public Law 93-288 as amended by the Robert T. Stafford Disaster Relief and Emergency Assistance Act of 1988, and/or stated financial assistance under the California Disaster Assistance Act; and

WHEREAS, the State of California Governor's Office of Emergency Services requires that a new Designation of Applicant's Agent Resolution for Non-State Agencies be filed if the previously submitted document is older than three (3) years from the last approved date or if there is a change in title of designees, and

WHEREAS, the County of Yuba wishes to designate the Director of Emergency Services, the Emergency Operations Manager, the Emergency Services Planner, the Assistant County Administrator, and the Auditor-Controller as its authorized agents.

NOW THEREFORE BE IT RESOLVED, the Board of Supervisors of the County of Yuba hereby:

1. Designates the Director of Emergency Services, the Emergency Operations Manager, the Emergency Services Planner, the Assistant County Administrator, and the Auditor-Controller as its authorized agents, who are herein designated to provide to the State Office of Emergency Services for all matters pertaining to such State and/or Federal disaster assistance the assurances and agreements required.
2. Authorizes these agents to apply for the 2021 Emergency Management Performance Grant, the 2021 Emergency Management Performance Grant - American Rescue Plan Act, the 2022 Emergency Management Performance Grant, the 2022 Emergency Management Performance Grant - American Rescue Plan Act, and the 2022 Homeland Security Grant

BE IT FURTHER RESOLVED, that the Board of Supervisors of Yuba County hereby orders the Clerk of the Board of Supervisors, in conjunction with the Office of Emergency Services and the Director of Emergency Services, to file a Cal OES Form 130, *Designation of Applicant's Agent Resolution for Non-State Agencies*, with the State of California Governor's Office of Emergency Services.






