WHEREAS, on July 12, 2022, the Board of Supervisors of the County of Yuba adopted Resolution number 2022-188 formally adopting the Classification System – Basic Salary/Hourly Schedule and the Yuba County Elected Officials Salary Schedule in its entirety effective July 1, 2022; and

WHEREAS, on August 23, 2022 the Board of Supervisors approved an amendment to the Classification System Basic Salary/Hourly Schedule as it related to updating the base pay rate and bargaining unit for the Chief DA Investigator effective August 1, 2022; and

WHEREAS, on September 13, 2022 the Board of Supervisors approved Memorandum of Understanding (MOU) between the County of Yuba and the Yuba County Law Enforcement Management Supervisory Association (MSA) effective September 1, 2022 through June 30, 2025, which includes a five percent (5%) cost of living adjustment (COLA) effective September 1, 2022; and

WHEREAS, on September 13, 2022 the Board of Supervisors approved the application of compensation changes related to the cost of living adjustments identified in the MSA MOU to Non-Represented Safety Management and Elected classifications within the Sheriff's Department; and

WHEREAS, the Board of Supervisors now intends to amend the Classification System – Basic Salary/Hourly Schedule as it relates to contractual agreements and as it relates to all classifications represented by MSA and the following Non-Represented Management Classifications within the Sheriff’s Department: Chief DA Investigator, Sheriff’s Captain, and Undersheriff; and

WHEREAS, the Board of Supervisors now intends to amend the Yuba County Elected Officials Salary Schedule as it relates to the following Non-Represented Elected Classification within the Sheriff’s Department: Sheriff/Coroner; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, the Classification System – Basic Salary/Hourly Schedule is hereby amended in its entirety as it relates to all classifications represented by MSA and the following Non-Represented Management Classifications within the Sheriff’s Department: Chief DA Investigator, Sheriff’s Captain, and Undersheriff; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors, the Yuba County Elected Officials Salary Schedule is hereby amended as it relates to following Non-Represented Elected Classification within the Sheriff’s Department: Sheriff/Coroner; and
