**WHEREAS**, the Treasury and Tax Manager position better reflects the level, scope of work, and specialized knowledge and skills required by the Treasurer – Tax Collector's Office operations; and

**WHEREAS**, the Board of Supervisors now intends to amend Resolution No. 2022-219 as it relates to the Departmental Position Allocation Schedule for the Treasurer – Tax Collector's Office.


